The Aloha Station Trust, LLC (the station), will conduct this Contest substantially as described in these rules, and by participating, each Participant agree as follows:

1. **DESCRIPTION OF CONTEST/PARTICIPATION.**

A. Dates of Contest: The Contest will begin on or about May 13, 2019 and will end on June 21, 2019 the Station may lengthen or shorten this time period.

NO PURCHASE NECESSARY. Void where prohibited. Odds of winning depend upon the number of Participants in each applicable entry category.

HOW TO ENTER:

- Contestants may listen everyday at approximately 7:20am for the Free Country Wake Up Crew to announce the song of the day. Once the song has been announced participants must listen for the song to play on 99.9 WFRE. When they hear the song of the day play on the station listeners must call in for their chance to be caller number 9 and win the song of the day prize. Once caller number 9 has been chosen the song of the day contest is done for that shift. The song of the day will play 3 times a day. It will only be announced on the air once a winner is selected. The song of the day will be different each day and is only valid for that day. Listeners who keep track of all the Songs of the Day can also enter to win \$500 gift card to Amazon.

All entries must be received no later than end time/date of the entry period for the applicable entry to be valid.

Prize: The prize(s) to be awarded only to each on air winner is a \$25 Amazon gift card. The station determines the winner. WFRE is not responsible for phone issues or disconnections.

(1) On-Air Entry Method: Beginning Monday, May 13, 2019. Please listen to the Station weekdays between 5:00:00 AM EST and 7:00:00 PM EST throughout the On-Air Entry Period for the cue to call in and be the selected caller for the Contest. Throughout the On-Air Entry Period, on each Entry Period Day (as listed above) the Song of the Day will play. There will be a randomly scheduled time each weekday (except National Holidays) during the On-Air Entry Period. The Station may or may not choose to announce exact times the cues will be played.

- Participant will be the designated caller, from all callers calling in to the Station's Contest line at (301) 695-9373; the designated caller, if eligible, will be declared a qualifier. If the Station determines the designated caller is not eligible, the Station may select the next eligible caller as the qualifier for that playtime. Listen to the Station for details on specific times to play.
- *The Station assumes no responsibility for Participants not making timely phone calls to the Station or other timed entry as a result of the delays in the Internet stream. Participants should not rely on streamed broadcasts. The station assumes no responsibility for dropped calls or disconnections.*



- *WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations and other delays in the online streaming of its broadcast signal. Listeners of the online stream may not be able to participate in, or may be disadvantaged in participating in on-air promotions and should contact Station to determine participation.*

(2) Listeners who keep track of the Songs of the Day can also enter to win a final prize of a \$500 Amazon Gift Card. They will get one entry into the final prize drawing for each Song of the Day they correctly name. If listeners knows all 29 songs they will receive triple the entries. Last day to submit online all songs of the day is June 24 at 5pmET. Winner will be randomly selected.

All entries are subject to any applicable restrictions or requirements listed herein. The Station is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties and other technological problems. The Released Parties (as defined below) are not responsible for lost, late, undeliverable, illegible, damaged, stolen, garbled, delayed, misdirected, mutilated, or incomplete entries or communications, regardless of cause. Multiple entrants are not permitted to share the same email address. Should multiple users of the same e-mail account or mobile phone number, as applicable, enter the Contest and a dispute thereafter arise regarding the identity of the entrant, the authorized account holder of said e-mail account or mobile phone account at the time of entry will be considered the entrant. "Authorized account holder" is defined as the natural person who is assigned an e-mail address or mobile phone number by an internet access provider, on-line service provider, telephone service provider or other organization which is responsible for assigning e-mail addresses, phone numbers or the domain associated with the submitted e-mail address. Proof of submission of an entry shall not be deemed proof of submission or receipt by the Website and/or Station for online entries. When applicable, the Station's computer will be deemed the official time keeping device for the Contest. Entries will be disqualified if found to be incomplete and/or if prohibited multiple entries are determined. Entries in excess of the above stated limit will be declared ineligible. All entries become the property of the Station and will not be receipt acknowledged or returned. Station's decisions as to the administration and operation of the Contest and the selection of potential winners are final and binding in all matters related to the Contest.

2. **ELIGIBILITY AND LIMITATIONS.** Participant(s) and winner(s) must be U.S. residents at least 21-years old as determined by the Station and reside in the Station's Total Survey Area (TSA). Only one prize per household for the Contest. Only one Grand Prize per household from any of the Stations within any thirty (30) day period. Employees of the Station, the Contest's participating sponsors and their advertising agencies, employees of other radio or television stations, and members of the immediate family of any such persons are not eligible to participate and win. The term "immediate family" includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as "in-laws," or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family extension, and any other persons residing at the same household whether or not related.

3. **TELEPHONE AND DELIVERY DISCLAIMER.** If a contest is a call in to win contest and/or a telephone is needed to participate in the Contest, participants are restricted to the use of ordinary telephone equipment. Participants that enable the "Caller ID" block function will not be allowed to participate unless they enter their correct area code and telephone number if prompted, or disable the features inhibiting their participation in the Contest. Participants using equipment not set up for toll free phone exchanges (800, 888, 877, 866, etc.) may experience call connection problems. The Company disclaims all liability for the inability of a participant to complete or continue a telephone call due to equipment malfunction, busy lines, inadvertent disconnections, acts beyond the Company's control, or otherwise. For all contests the Company disclaims all liability for any delays, misdelivery, loss, or failure in the delivery of any item sent by mail, courier, express, electronic transmission, or other delivery method. By participating in the Contest, where allowed by law, participants agree that the Company may disclose personal information obtained from participants in the Contest to third parties and use such information for marketing and other purposes.



5. **RELEASE.** By participating in the Contest, each Participant and winner waives any and all claims of liability against the Station, its employees and agents, the Contest's sponsors and their respective employees and agents, for any personal injury or loss which may occur from the conduct of, or participation in, the Contest, or from the use of any prize. In order to receive a prize, participants must sign an official waiver form provided by the Company.

6. **TAXES.** Any valuation of the prize(s) stated above is based on available information provided to the Station, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner is solely responsible for reporting and paying any and all applicable taxes related to the prize(s) and paying any expenses associated with any prize which are not specifically provided for in the official rules. Each winner must provide the Station with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from the Station will receive an IRS form 1099 at the end of the calendar year and a copy of such Form will be submitted by station to the IRS.

7. **CONDUCT AND DECISIONS.** By participating in the Contest, Participants agree to be bound by the decisions of Station personnel. Persons who violate any rule, gain unfair advantage in participating in the Contest, or obtain winner status using fraudulent means will be disqualified. Unsportsmanlike, disruptive, annoying, harassing or threatening behavior is prohibited. The Station will interpret these rules and resolve any disputes, conflicting claims or ambiguities concerning the rules or the Contest and the Station's decisions concerning such disputes shall be final. If the conduct or outcome of the Contest is affected by human error, any mechanical malfunctions or failures of any kind, intentional interference or any event beyond the control of the Station, the Station reserves the right to terminate this Contest, or make such other decisions regarding the outcome as the Station deems appropriate. All decisions will be made by the Company and are final. The Company may waive any of these rules in its sole discretion. ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY CIRCUMVENT, DISRUPT OR DAMAGE ORDINARY AND NORMAL OPERATION OF THIS CONTEST, TELEPHONE SYSTEMS OR WEBSITES, OR UNDERMINE THE LEGITIMATE OPERATION OF THE CONTEST IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, STATION RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PARTICIPANT TO THE FULLEST EXTENT PERMITTED BY LAW.

8. **MISCELLANEOUS.** Each winner must submit proof of eligibility and sign the Station's release form to claim the prize. The Station may substitute prizes, amend the rules or discontinue the Contest at any time as announced on the Station(s). The Station disclaims any responsibility to notify participants of any aspect related to the conduct of the Contest. For a copy of the rules, or where required by law, a list of winners, visit the business office of the Station during normal business hours or mail a written request with a stamped, self-addressed return envelope to the Station's address, listed above. All entries become the property of the Station and will not be returned. The station reserves the right to edit, update or modify the contest rules at any point in time.

9. **COMPLIANCE WITH LAW.** The conduct of the Contest is governed by the applicable laws of the United States of America, and the State of Maryland which take precedence over any rule to the contrary herein. The Station shall follow the applicable laws for conducting contests, including notice to the state attorney general or consumer affairs office, posting of a prize bond, furnishing lists of winners, running specific on-air disclaimers, providing specific written information about the Contest, etc. as required by local and state law.
